1. Gaming Site Extension – Grand Hotel, Candle Light Room – MSU Alumni Association

The City has received a request from MSU Alumni Association for an extension of their site authorization to include the Convention Center at the Grand Hotel, 1505 North Broadway for the Y's Men Rodeo October 6th and 7th, 2016.

It is recommended the Committee and Council authorize gaming site authorization extension of premises from MSU Alumni Association at the Grand Hotel on October 6th and 7th for a special event.
