PLEDGE OF ALLEGIANCE

Mayor Sipma presiding and led the City Council in the Pledge of Allegiance.

PROCLAMATION: SUMMER OF READING

City of Minot Mayor Proclaims summer of 2021 as the Summer of Reading for 20.

WHEREAS, research has proven that reading for just 20 minutes a day can drastically improve students' test scores and increase their vocabulary;

WHEREAS, reading will not only help in school success, but will stimulate imagination which can introduce children to concepts, cultures, and possibilities beyond their own experiences and thereby builds empathy;

WHEREAS, when children read for 20 minutes a day they could be hearing (and thus learning) up to 1.8 million words per year;

WHEREAS, adults who read for at least 20 minutes each day sharpen a variety of skills that are valuable in the workforce, including memory retention, social-emotional skills and critical thinking;

WHEREAS, the experience of being read to helps children develop good listening skills by making them aware of the important components of language;

WHEREAS, families who read together for 20 minutes a day, 7 days a week, will get 121 hours of bonding time every year;

WHEREAS, research by the National Literacy Trust found that 90% of children feel happiest when reading and writing rather than playing video games or watching television;

WHEREAS, young adults who enter college without established reading habits will struggle to focus, develop critical thinking skills, and understand complex issues;

WHEREAS, the ability to focus for 20 minutes helps lead to informed voters and involved citizens who can critically evaluate issues;

NOW, THEREFORE, be it resolved that I, Shaun Sipma, Mayor of Minot, ND, proclaim the summer of 2021 as the Summer of Reading for 20. During this summer, I encourage all residents to join together to promote the Read for 20 campaign by making the time to read on your own or with a child for 20 minutes every day.

PROCLAMATION: PUBLIC WORKS WEEK

City of Minot Mayor Proclaims May 16 – 22, 2021 National Public Works Week, "Stronger Together"

WHEREAS, public works professionals focus on infrastructure, facilities and services that are of vital importance to sustainable and resilient communities and to the public health, high quality of life and well-being of the people of Minot North Dakota; and.

WHEREAS, these infrastructure, facilities and services could not be provided without the dedicated efforts of public works professionals, who are engineers, managers and employees at all levels of government and the private sector, who are responsible for rebuilding, improving and protecting our nation's transportation, water supply, water treatment and solid waste systems, public buildings, and other structures and facilities essential for our citizens; and,

WHEREAS, it is in the public interest for the citizens, civic leaders and children in Minot to gain knowledge of and to maintain an ongoing interest and understanding of the importance of public works and public works programs in their respective communities; and,

WHEREAS, the year 2021 marks the 61st annual National Public Works Week sponsored by the American Public Works Association/Canadian Public Works Association,

NOW, THEREFORE, be it resolved that I, Shaun Sipma, Mayor of Minot, ND, do hereby designate the week May 16 – 22, 2021 as National Public Works Week; I urge all citizens to join with representatives of the American Public Works Association/Canadian Public Works Association and government agencies in activities, events and ceremonies designed to pay tribute to our public works professionals, engineers, managers and employees and to recognize the substantial contributions they make to protecting our national health, safety, and quality of life.

2021 LEGISLATIVE SESSION RECAP

Shane Goettle, Special Assistant City Attorney, provided a recap of the Legislative Session. He said, they wrapped up on April 29, 2021 after 76 days of session. There were 914 bills and resolutions introduced; 500 passed each chamber and 29 were withdrawn. The Legislature passed a record \$16.9 billion two-year budget which includes \$5 billion in state general fund spending but results in no tax increase. He then explained the Hub City funding formula and said it remained intact without change this session.

Mr. Goettle continued by describing various bills relating to Water Commission Budget and bonding, including funding for the Mouse River Enhanced Flood Protection Project (MREFPP) and Northwest Area Water Supply (NAWS). He also explained bills affecting the Legacy Fund, COVID-19, Neighborhood Support Zones, Local Taxation, Restrictions During Emergency Conditions, Changes to City Elections, Restrictions on City Governance, and the Intermodal Facility. He reviewed what each bill encompassed and provided an update on the status of each bill affecting Minot. He said, the 2021-2022 Interim may include a special session for CARES ACT dollars, a special session for redistricting as well as interim studies and committees.

Following the presentation, Mayor Sipma also pointed out the weekly League of Cities meetings and numerous correspondence Mr. Goettle provided throughout the session.

Alderwoman Evans thanked Mr. Goettle and staff for their testimony and expertise during the Legislative Session.

CITY MANAGER REPORT

The City Manager provided a written update describing events and activities for various departments.

Mr. Stewart reminded the Council of the Budget Tours taking place over the next two weeks and the work session May 24th, focused on economic development. He also mentioned attending the Williston Petroleum Conference.

He then stated, there was an issue regarding a record request made last year in which notes that were considered by the City to be attorney work product, were not produced to the requester of those notes. The requester appealed to the Attorney General and an opinion was released last week requiring the City to release the notes. In an effort to increase transparency to all who have since requested the documents, a copy will be available on the City website. He said, he hopes this resolves the situation and allows the City to move forward in a positive and productive way.

Alderman Pitner moved the City Council authorize a lease with Caterpillar Financial Services Corporation for the new landfill scraper that was awarded to Butler Machinery in December of 2020. Also, authorize the Mayor to sign the Governmental Entity Resolution to Lease document within the lease and other associated documents.

Motion seconded by Alderman Ross and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

CONCUR ON PURCHASE PRICE FOR FLOOD BUYOUT AT 1212 28TH STREET SW AT \$138,000 – APPROVED

Alderman Pitner moved the City Council concur with the negotiated purchase price of \$138,000 for Flood buyout acquisition at 1212 28th Street SW owned by Patricia Bender and Michael Wilson.

Motion seconded by Alderman Ross and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

DELEGATION OF AUTHORITY - ND STATE FIRE MARSHAL - APPROVED

Alderman Pitner moved the City Council authorize the Fire Chief to sign the Delegation of Authority from the North Dakota State Fire Marshal's Office to allow the Authority Having Jurisdiction (AHJ) to have code responsibility for schools, State buildings and residential State buildings within the City of Minot.

Motion seconded by Alderman Ross and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

LETTER TO SURFACE TRANSPORTATION BOARD DOWNTOWN RAIL TRANSFER – APPROVED

Alderman Pitner moved the City Council authorize the Mayor to send a letter to the Surface Transportation Board stating the City's concerns about a transfer operation change with BNSF.

Motion seconded by Alderman Ross and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

APPROVAL OF CONTRACT WITH ND OFFICE OF STATE TAX COMMISSIONER FOR COLLECTION OF CITY SALES TAX – APPROVED

Alderman Pitner moved the City Council approve the contract with the ND State Tax Commissioner to collect City sales tax for the period of July 1, 2021 to June 30, 2021 and authorize the Finance Director to sign the contract.

Motion seconded by Alderman Ross and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

REPORT ON 1901 SOUTH BROADWAY (BROADWAY CIRCLE LMI HOUSING/FAMILY HOMELESS SHELTER PROJECT) – APPROVED

The NDR Grant Program Manager provided a written report on the LMI Housing/Family Homeless Shelter project with no City Council action needed.

MINOT INTERMODAL FACILITY CRISI GRANT UPDATE (4546) - APPROVED

In May of 2020, the City and NDDOT signed an agreement to accept funds from the Federal Railway Administration's CRISI grant program for a study of intermodal operations and planning. Because of changes to intermodal service by BNSF, the scope of work in the agreement has been updated. Staff provided and updated scope for the Council to review so there is understanding of how the study is being undertaken. No action is required.

MINOT AIRPORT PARKING FACILITIES MANAGEMENT AGREEMENT – APPROVED

Airport Director, Rick Feltner, explained that Minot Airport has had the same parking vendor for ten years. Since the beginning of the relationship, there have been advances in parking and new technology. Parking is the number one non-aeronautical source of revenue for the Airport so they strive to effectively manage this revenue source. Since the end of the current contract was approaching, Airport staff issued a Request for Proposals. They received five submissions which were evaluated and ranked accordingly and LAZ Parking was found to be the best solution. He said, they will be moving from a management-fee based operation to a concession-based operation which will move the risk onto the concessionaire.

Alderwoman Evans asked what type of operations other North Dakota communities use, to which the Airport Services Coordinator, Maria Romanick, said, the operations vary depending on the community. Grand Forks uses a management fee operation whereas Williston uses an app and remains unstaffed.

The Airport Director then introduced Stuart Vieth, Senior Director of US Airports and Brendon Bowen, Regional Vice President, of LAZ Parking. Mr. Veith stated, they would be the team operating in Minot and he provided some background about the company. Mr. Bowen explained some of the technological solutions for parking, including an app/website called LAZgo. He assured the advances in technology will be in addition to methods currently used in parking operations.

Following the presentation, Alderman Ross moved the City Council approve the parking management contract with LAZ Parking for management of the Airport's parking lots, approve parking equipment procurement/purchase and authorize the Mayor to sign the agreement.

Motion seconded by Alderman Jantzer and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

AGREEMENT WITH PARK DISTRICT FOR USE OF CITY LOTS – APPROVED

Alderwoman Evans moved the City Council approve the revised Joint Powers Agreement with the Minot Park District for use of City properties for flower gardens and small park areas, until they are needed for the future flood protection project.

Motion seconded by Alderman Jantzer and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

RESTORATION EFFORT FOR FLOOD BUYOUT PROPERTIES NOT NEEDED FOR FLOOD CONTROL PROJECTS – APPROVED

Alderman Podrygula moved the City Council approve the following staff recommendations relating to restoration effort for flood buyout properties not needed for Flood Control projects:

- Establish an Ecological Restoration and Improvement Task Force comprised of a City Council liaison, DR Program Manager, City Engineer, Public Works Director, Community and Economic Development Director, Audubon Society, Minot Park District and Souris River Joint Board for the purpose of identifying projects consistent with flood protection and encouraging Minot residents to enjoy the natural environment at or near the river
- City negotiate with the Audubon Society of North Dakota a sub-recipient agreement to leverage CDBG-NDR Ecological Restoration funds with Society's grant resources in support of projects identified through the Task Force
- Develop design and implementation strategies for projects identified through the Task Force
- Develop a joint operating agreement or similar agreement between the Minot Park District and the City of Minot for the construction and/or maintenance and use of projects funded and authorized as a result of the Task Force Work
- Regularly report to the City Council on the work of the Task Force, present to the City Council for approval projects identified for implementation, and present to the City any agreements including the sub-recipient agreement and the joint operating agreement for approval needed for projects' implementation

Motion seconded by Alderwoman Evans and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

APPROVE CDBG-NDR SUBSTANTIAL AMENDMENT #5 – APPROVED

Alderwoman Olson moved the City Council approve CDBG-NDR Substantial Amendment #5 to add beneficiaries to relocation services for tenants currently located in the former Wells Fargo Building which has been identified for the relocation of City Hall. Motion seconded by Alderman Jantzer.

Alderwoman Evans asked how many tenants would be affected, to which the City Engineer stated, there are six total tenants and two are long term, the rest are month to month.

A vote was taken on the above motion by Alderwoman Olson, seconded by Alderman Jantzer and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

APPROVE MINOR MODIFICATION TO TERMINATION AGREEMENT WITH LIGHTHOUSE MANAGEMENT – APPROVED

Alderwoman Evans moved the City Council approve a modification to the Termination Agreement with Lighthouse Management. Motion seconded by Alderwoman Olson.

Alderman Pitner asked if there would be additional action for Council in the future or if this conveyed the property to the City.

Mr. Zakian, NDR Grant Program Manager, stated, the agreement conveying the property to the City was court ordered, signed and approved. The next steps will include discussions with nonprofits interested in operating the facility. They will negotiate a subrecipient agreement which would then be brought back to Council for approval.

Alderman Pitner shared his support for the project but raised concerns over the location. He said he would still like to see a different site thought out, taking into consideration the high vehicle traffic in that area and the Broadway Corridor study.

Alderman Jantzer pointed out, the Broadway Corridor study will improve pedestrian access around Broadway and provide solutions to his concerns. He also said, NDR funds cannot be expended for operations which is why this site, that includes and active tenant provides income to operate the rest of the project.

Alderman Ross said he agreed with Alderman Pitner and believes there are safer options available which should be fully explored first.

Whereupon a vote was taken on the above motion by Alderwoman Evans seconded by Alderwoman Olson and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Podrygula, Ross, Sipma; nays: none.

10TH ANNIVERSARY OF THE FLOOD EVENT PLANNER CONTRACT – APPROVED

Alderwoman Evans moved the City Council approve the contract between the City of Minot and Hometown Elegance Event Catering and Productions for consultation of the 10th Anniversary & commemoration of the 2011 flood. Motion seconded by Alderman Pitner.

Mayor Sipma explained that since June 26th will be the ten-year anniversary of the 2011 flood, he pulled together a committee consisting of members who were affected by the flood. It includes representatives from the County, surrounding communities and local partners. They are planning for a full day event at Oak Park that will involve a memory walk throughout the park with memorial and commemoration of the past and future. There will be quite a few dignitaries in attendance, some entertainment and a roundtable discussion on the flood fight and recovery. There will also be a ribbon cutting and dedication for the completion of Phases MI-2 & MI-3 of the Flood Project. There could potentially be bike ride from Burlington to Minot, a motorcycle run from Mouse River Park to Oak Park and 5k run throughout. Their intention was to have as many people involved as possible while recognizing the flood and focusing on recovery. Mr. Zakian confirmed that NDR dollars could be used for the expense of the event planner, however, the committee is reaching out for sponsorships to defray the costs.

Alderwoman Evans stated, her hesitation with the item was regarding the lack of communication surrounding the event. She acknowledged that it is an important part of history but said they were unaware of any events taking place.

The Mayor listed the members of the committee including himself, a Ward County Commissioner, Parks & Recreation, Mayor of Burlington, and a number of dignitaries. He said, the intent was for the committee to conduct the planning and roll it out as quickly as they could.

Alderwoman Olson asked if the other entities involved with planning would be contributing to the costs as well.

Mayor Sipma said, they identified NDR funds as the funding source however, they are working on programming to tie the communities together, so other items will be unveiled in which they can take part in.

Alderman Podrygula said he is not supportive of the motion or of the event. He stated, everyone responds differently to emotional circumstances and some are more comfortable with a somber recollection of the event. The commemoration described by the Mayor could be interpreted as a celebration and he believes they need to reflect on progress but not celebrate the events of the flood.

Alderman Pitner asked if the event coordinator was looking for sponsors or who he should contact if interested in being a sponsor.

Mayor Sipma stated, the sponsorship letters will come from him but they can reach out to the event planner to coordinate.

Alderwoman Evans addressed Alderman Podrygula's comments by saying, the event is to acknowledge the resilience of Minot and celebrate how far we've come to rebuild.

Mayor Sipma added, the attendees can participate at their own comfort level but the goal is to commemorate the progress since the flood. They will not sound the sirens since that is too hard for many people who still suffer from PTSD. He wants to recognize the community for its' ability to recover after tragedy and he assured the Council that the event is collectively thought out.

Alderwoman Evans suggested Alderman Podrygula work with mental health professionals to be on hand during the event. Mayor Sipma stated, the Burlington Mayor is already working to accomplish that.

Alderman Ross commented that since this is the first the Council has been made aware of the event, they were not able to share their different perspectives until now. He said he understands celebrating victories but a lot of the population is still hurting.

Whereupon a vote was taken on the above motion by Alderwoman Evans, seconded by Alderman Pitner and carried by the following roll call vote: ayes: Evans, Jantzer, Olson, Pitner, Ross, Sipma; nays: Podrygula

PERSONAL APPEARANCES

Neal Jensen of Minot, spoke in support of the Family Homeless Shelter project. He said, he has worked with the Lord's Cupboard Food Pantry for years and although he understands the concerns over the location, the project is not just a homeless shelter. The project will include services to reorient people into the community and provide limited basis transitional housing. He was also optimistic for a medically inclined option to take over operation of the facility.

MISCELLANEOUS & DISCUSSION

Alderman Podrygula brought up City permits and fees and the rising costs of delivering services. There is currently no process in place for assessment of fees so he requested the City Manager work on a policy to conduct annual evaluations of fees tied to the cost of living or the cost of issuance. He said there should also be allowances for public discussion.

LIAISION REPORTS

Alderman Pitner mentioned sitting on the Battalion Chief Assessment, which had several great candidates.

Alderman Jantzer had no meetings to report.

Alderman Ross said the Zoning Ordinance Steering Committee will resume meetings in June where they will address the Subdivision ordinance.

Mayor Sipma met with the Chamber EDC which is working on moving the Intermodal facility forward. Alderman Jantzer

Alderwoman Evans said Library traffic is higher than it has been in several years. They are currently working on a website update. She reminded the public that the Library allows patrons to borrow music, movies, tools and more.

Alderwoman Olson said the City Hall building is moving forward with floor plan options and is working at a good consistent pace. The CTE is working on a purchase agreement for the property and Souris Basin Planning Council has not met.

Alderman Podrygula said the Emergency Resource Council is dealing with the drought and how Fire Departments have been strained. They are hoping for updates on the water supply. He also said, Ward County Planning Commission meets on Thursday and the Commission on Aging meets on Friday.

The Mayor then wished everyone a happy Syttende Mai, especially to Minot's Sister City Skien, Norway.
